

- All construction of any dwelling or out-building as well as meeting WMHOA covenants, is required
 to abide by Douglas county laws, building and health department guidelines, following the county
 maintained permit-inspection process where applicable.
- Owners proposing new original construction or exterior renovation must submit to the Woodmoor Mountain Home Owner's Assoc., Architectural Control Committee (ACC) a full set of approved architectural drawings with color chips for exterior colors along with roof and fencing material samples, if applicable.
- Show illustratively (survey plat) how proposed construction adheres to WMHOA covenant 40' setback requirement from roadways and adjacent properties. Additionally, show proposed driveway, drainage plan, well and septic/leach field locations noting health department separation requirement between anvento-separation requirement between anvento-separation requirement field.
- In essay form, propose how construction trash removal and toilet needs (required by Tri-County Health/Douglas County) will be handled.
